

NOTICE OF REFERENDUM
JOINT SCHOOL DISTRICT NUMBER 2, VILLAGES OF FOX POINT AND BAYSIDE
NOVEMBER 6, 2018

NOTICE IS HEREBY GIVEN, that at an election to be held in the Joint School District Number 2, Villages of Fox Point and Bayside on November 6, 2018, the following proposed Revenue Limit Resolution of the School Board will be submitted to a vote of the people:

RESOLUTION AUTHORIZING THE SCHOOL DISTRICT BUDGET
TO EXCEED REVENUE LIMIT BY \$3.1 MILLION PER YEAR FOR
FOUR YEARS FOR NON-RECURRING PURPOSES

BE IT RESOLVED by the School Board of the Joint School District Number 2, Villages of Fox Point and Bayside, Milwaukee and Ozaukee Counties, Wisconsin that the revenues included in the School District budget be authorized to exceed the revenue limit specified in Section 121.91, Wisconsin Statutes, by \$3.1 million per year for non-recurring purposes for the 2019-2020 school year through the 2022-2023 school year, in order to maintain and support instructional programs, services, and class sizes.

The question will appear on the ballot as follows:

“Shall the Joint School District Number 2, Villages of Fox Point and Bayside, Milwaukee and Ozaukee Counties, Wisconsin be authorized to exceed the revenue limit specified in Section 121.91, Wisconsin Statutes, by \$3.1 million per year for non-recurring purposes for the 2019-2020 school year through the 2022-2023 school year, in order to maintain and support instructional programs, services, and class sizes?”

EXPLANATORY STATEMENT AND EFFECT OF VOTE

The referendum election ballot will ask District electors to vote “yes” or “no” on the referendum election question as set forth above.

A “yes” vote on the question is a vote to authorize the Joint School District Number 2, Villages of Fox Point and Bayside budget to exceed the revenue limit specified in Section 121.91, Wisconsin Statutes, by \$3.1 million per year for non-recurring purposes for the 2019-2020 school year through the 2022-2023 school year, in order to maintain and support instruction programs, services, and class sizes.

A “no” vote on the question is a vote to deny the Joint School District Number 2, Villages of Fox Point and Bayside the authority to exceed the revenue limit specified in Section 121.91, Wisconsin Statutes, by \$3.1 million per year for non-recurring purposes for the 2019-2020 school year through the 2022-2023 school year, in order to maintain and support instructional programs, services, and class sizes.

In the event a majority of the electors voting on the question vote “yes”, the District will be authorized to exceed the revenue limit specified in Section 121.91, Wisconsin Statutes, by \$3.1 million per year for non-recurring purposes for the 2019-2020 school year through the 2022-2023 school year, in order to maintain and support instructional programs, services, and class sizes; if a majority vote “no” on the question set forth above, the District will not be so authorized.
